REPORT OF THE EXTERNAL ACADEMIC AUDIT FOR THE ACADEMIC YEAR 2022-2023 OF HINDUSTHAN COLLEGE OF ARTS & SCIENCE (AUTONOMOUS)

Consolidated Report on the Observations and Comments made by the External Auditors:

The External Academic Audit was conducted for the Academic year 2022-2023 on 28th October 2023 at Hindusthan College of Arts & Science (A), Coimbatore -641028 along with 4 member's team namely. 1. Dr. N. Ponpandian, Professor & Head, Department of Nano Science & Technology, Bharathiar University, Coimbatore-46, 2. Dr. Parimelazhagan, Professor & Head, Department of Botany, Bharathiar University, 3. Dr. S. Sampathkumar, Professor & Head, Department of Sociology & Population Studies, Bharathiar University and 4. Dr. M. Nagarajan Principal, KSG College of Arts & Science, Coimbatore-15.

The External Academic Audit is conducted to assess the effectiveness of the Management Control System and the extent to which the Academic Department and Supportive services are in accordance with the relevant rules, laws policies and standards. The standard procedure of External Academic Audit entails physical inspection and review of the pertinent documents of the Academic Departments and supportive services, interviews, meetings and abstract information obtained from the relevant Academic Departments in addition to reviewing the Report of Internal Academic Audit carried out by the Internal academic Auditors.

This Report is based on the Report of Internal Academic Audit and External Academic Auditor's meeting with IQAC and Heads of the Departments.. During the visit of the departments, the auditors shared their views and suggestions with the principal and heads of the various departments.

I. CURRICULAR ASPECTS:

The audit team very much appreciated the curriculum, OBE pattern on the courses, fast track system and extra credit courses introduced by the departments and also appreciated the interdisciplinary courses and faculty exchange programmes.

All the major Academic Departments have significantly revised and updated their curricula to meet local, national and worldwide needs while putting a focus on recent advancements and trends, enhancement employability, entrepreneurship and skill development received a lot of attention. Majority of the Academic departments have introduced new courses.

As suggested by the audit team during the previous year increased number of elective courses and prepared action taken files on feed back analysis regarding curriculum from the AY 2022-2023 and the same was appreciated by the audit team. The Team suggested to curriculum revision i.e., addition and deletion should be clearly mentioned in the report as well suggested to follow the uniformity of certificates for Value Added Courses.

II. TEACHING, LEARNING AND EVALUATION:

Academic planners and work diaries have been meticulously prepared and maintained by all the faculty members of the college for the Academic year 2022-2023. Many of the faculty members have participated in BOS meetings, DC meetings and External examinations. Auditor were insisted the Faculty members to maintain proper records for slow learners and advance learners in the departments as well uniformity of the same. They also emphasize the faculties to maintain the records for the mentor and mentee with the details of student's progress and counseling given to them. Extension activity done by the departments is appreciable. Faculty members are to be motivated to attend more number of Orientation programme and conferences in local and abroad.

III. RESEARCH AND INNOVATION:

Faculty members and research Scholars have published many articles in UGC care listed journals and also published books during the Academic Year 2022-2023. The audit team has specifically mentioned about more number of interdisciplinary and collaborative activities and also they suggested increasing the quality publications in Scopus/web of science etc., and they were asked to strengthen the research by providing more time to read latest literature and design new research problems and improve the publication quality and funding project from various governmental and NGOs. The team asked the faculty members to authored books copy right can be in the name of the college.

IV. INFRASTRUCTURAL FACILITIES:

The college has excellent infrastructural facilities for sports and games including an Gym, indoor stadium and play ground. As suggested by the auditors during the previous audit, Hindusthan College has installed ICT, Wi-Fi and LCD projectors equipped with Smart boards in the class rooms, so they were so happy and appreciated this improvement. The team suggested providing sufficient number of new computers along with printers to the departments as well safety measures and sufficient number of first aid equipments to be given in all the departments and labs.

V. STUDENT SUPPORT AND PROGRESSION:

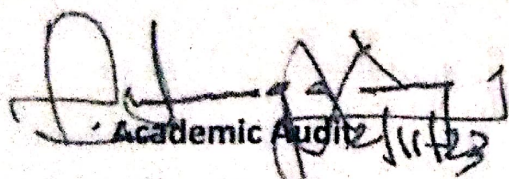

VI. OFFICE OF THE CONTROLLER OF THE EXAMINATIONS:

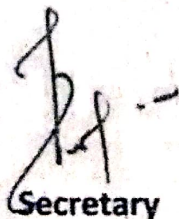

VII. OVERALL REPORT OF THE DEPARTMENTS:

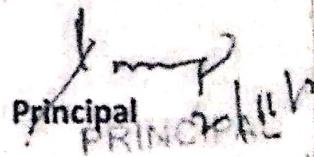
