

In the syllabus of PG 2021-2022, Semester -III, 21CCP15, Advanced Management Accounting, rearrangement of few contents in unit II, III and V


In the syllabus of PG 2021-2022, Semester -IV, 22CCP24 A, Organizational Behavior (Elective -DSE IV) new course has been introduced.
